On February 3, 2019, I participated in the Regional Meeting via Zoom.

- ITCC proposed using G Suite
 - Emails for Trusted Servants.
 - TEAM Drives which is a drive that offers free cloud-based storage to enables users to store and access files online. We can create a Secretary's drive, Treasurer's drive, budgets can be easily kept to be accessed by future trusted servants looking for examples of setting up their budgets. Trusted servants could upload their reports to the Secretary's drive
 - Folders can be created in each drive. This is similar to folders you create on your computer.
 - Various permission levels for these drives and folders are available. Public-Only Trusted
 Servants of the region or Members of your Team (PR/H&I/Outreach)
 - Google Docs/Sheets/Slides/Forms Documents/spreadsheets/PowerPoints, etc can be created and saved right in the Google Drives
 - Google Groups VRSC Trusted servants or Subcommittee groups to be used if there is something we only want to go to trusted servants.
 - Ad Words Up to \$10,000 free each month. We can use this to attract potential members
 or professionals looking for more information to our website. When someone searches
 for "drug problem" our website would show up in the search.
- H&I Chair, Eric P was introduced
- Some of the things that our Regional and Area Public Relations Committees are doing include, but are not limited to, PR booths, presentations, putting literature in public libraries, flyer hanging days, and getting new members excited about PR! The Mid-West Area is holding a PR

booth at a 3-day event in April and have requested the use of the Region's presentation board, which they are excited to accommodate. They also learned that a few of our Areas need some assistance providing literature to go in our literature racks in public places where addicts frequent. The main purpose is to help the PR committees within our Region, and providing some IPs is absolutely something they can do. They have also made contact with the State Senator who is the Chair of the State's Health and Welfare Committee and plan to do a presentation for that committee and hopefully even to the Governor! They also have contacted the person in charge of a state website of resources called thtogether.com and corrected the link which was supposed to send people to an NA website, but instead was sending them to something the state was doing around peer recovery specialists.

- Here is a brief summary of some pertinent figures from VRC 36: Registrations: Total 449 89 Early Bird, 117 Pre-registrations and 243 Registrations, Newcomer Donations: \$793.73, Entertainment: 140 Comedy Show Tickets Sold, 99 Concert Tickets Sold, Fundraising: \$3,168.04 raised in the Auction Merchandise: \$4,384.87 sold at the convention Merchandise sold out :), Hotel Liaison: 100 Banquet tickets sold, 46 Brunch tickets sold. The committee cleared \$6,194.91 and stated since the purpose of VRC 36 was to carry the message, provide a venue for fellowship and not lose money in the process the mission was accomplished.
- VRC 37 is glad to report they are running hard but are a little bit understaffed. They have a bank account now and are using SunTrust Bank. The first payment to the Marriott was made on January 21. The total with the hotel is \$2426 if room block is met. The theme is set as: The Labor of Love. Artwork will be voted on at the next committee meeting. They need registrations and room reservations at this time. VRC 37 was placed on the na.org website and ask the event is placed on regional and area websites.
- VRC Guideline AdHoc Committee discussed what changes are being proposed to the guidelines and presented those changes as recommendations to the VRSC. They recommended a timeline of the guideline revision in relation to implementation and coordinating with the new quarterly schedule of the VRSC meeting. They determined that VRC would be on a 2-year commitment to comply with the new VRSC schedule. They also recommended the schedule that would follow. I have include both documents.
- Nominations voted on. I failed to obtain the votes from the groups at the last Area. The only vote I could confirm was Primary Purpose to I voted the rest of the groups as Present But Not Voting. All three (3) positions passed: Lucy O as ITTC Chair; Lydia S as Outreach Chair, Michelle H for Treasurer

In addition, we are bringing back the meeting of the month. So if any groups have any suggestions please let me know. We need support and will need help setting up and carrying the service fair.

• <u>Clean Steam</u> -Hello Family. All is well at Clean Steam. We have had an average of 7 in attendance and one newcomer.

- <u>Clarity</u> All is well at Clarity. We continue to have good attendance. Averaging 45 people.
 We had several newcomers. We are planning on starting our guest speakers in March. If interested please contact Corey B.
- <u>Cordova Hope</u> Everything is going well at Cordova Hope. We have anywhere from 20-40 attendants. We are excited to have an alternate GSR, since we haven't had one in years

W are "considering" holding regular speaker jams. Details are incomplete. Stay tuned. Our meetings are open. We offer a warm welcome to newcomers and visitors. Recovery

- programs are often in attendance. The Lunch Bunch provides snacks and the best coffee in the New-nited States. Come on down!
- One is Too Many All is well with One is too many. No new members. No newcomers. We will
 have our monthly speaker meeting on 3/29/2019. We have an average of 12 in attendance at
 each meeting.

Hello,

We are writing with exciting news. The review draft of the *Mental Health in Recovery* informational pamphlet (IP) is posted on the NAWS website! www.na.org/mhmi. This IP is intended to support members in recovery who face mental health challenges.

Project Background:

This project stemmed from both a regional motion and the literature survey in the *Conference Agenda Report*. WSC 2016 approved a motion: "That the NA World Board develop a project plan which includes a budget and timeline to create an information pamphlet specifically about mental illness and recovery for consideration at the 2018 World Service Conference." The Conference supported this motion (93-17-1), and the mental health pamphlet received a high priority ranking in the WSC literature survey. WSC 2018 approved a plan for the project, and the World Board formed a workgroup to develop the IP.

Draft Information

Prior to the formation of the project workgroup, we had received 792 pieces of input from members in 26 countries. We are pleased to be able to reflect much of what we heard in this draft. The pamphlet draft has topic headings to assist members who have specific concerns. Some important points are restated in the pamphlet to emphasize their significance. Because this IP is intended to reflect and support the experience of our members, we have included quotes from individual members and NA recovery literature.

Review and Input Questions

This pamphlet is primarily intended to help members in recovery who face mental health challenges. We have included a list of questions about the draft in the cover memo. Focusing

your input on these questions will help us to make the draft more useful and beneficial to members. Thank you very much for your help in creating NA literature.

We will accept your input in whatever form it is offered. However, we prefer you to fill out the online form if possible: www.na.org/mhmi. Input will be received until May 15, 2019.
