<u>Desire</u> –All is well at Desire. We had action-packed month of birthday celebrations and we continue to have high attendance with a lot of newcomers. Come join us to share a message of recovery.

GIFT – All is well. 2 newcomers. Average 5 addicts per meeting

Get Honest or Die – All is well. Gene is celebrating 34 years and Andrew is celebrating 2 years on August 20th.

Harmony – Hello family. All is well at Harmony. Average attendance is 15 with 2 newcomers.

<u>High On Life</u> –Greetings. All is well at HOL and we still meet Monday at 8:30 and still come out of the lit for our topics. We have three birthdays on Monday July 30th. Ruth H aka Kay Kay 1 yr clean, Paula H 2 yrs, and Chris D 21 yrs. We had a total of 80 addicts including one rehab. We have a lit order of \$25.35 and no donation to area for a total of \$25.35.

<u>Hopenminded</u> – Here at hopenminded we are doing great! We had an average 15-20 people per meeting including treatment centers. We had 15 newcomers come into the meeting. We added 1 home group member.

<u>Keep it Green</u> – Great attendance. Everything the same.

<u>Lunch Bunch</u> – Lunch Bunch continues to have meetings 7 days a week. Tuesdays & Thursdays tend to be having treatment centers and we could use support from recovering addicts sharing their experience, strength, and hope.

<u>One is Too Many</u> – One is too Many is doing well. We had 2 newcomers. We will have a speaker meeting next Friday. We continue to have an average of 15 people at each meeting.

<u>Primary Purpose</u> – All is well at Primary Promise. We have an average attendance of 15-20 addicts a meeting with 2 newcomers last month.

<u>Saturday Night Alive</u> – Everything is going well at SNA. We appreciate Outreach's support this month. They Rock!

Simplicity is the Key – We have had a blessed month at SITK. We had 121 addicts attend our meeting and 6 new comers.

<u>Something Different</u> – Presently, everything at Something Different is positive with no problems. We are averaging 20 plus people per meeting. We have added 2 new home group members this month.

<u>Spiritual Awakenings</u> – All is well at SA. We continue to have 20-30 addicts in attendance. Added 1 new home group members.

OPEN FORUM TOPICS

Amanda's amends -

My name is Amanda and I am an addict.

Thank you for giving me a moment to speak. The purpose of my sharing is to own my part in a situation caused by my own ego and self-righteousness. As NA in May Chair, I brought a motion and with that motion came judgement and ego. Taylor O - as P&P chair you brought up a discussion and attempted to explain our guidelines that I shot down and dismissed. I took it personally and quickly became defensive. I hid behind my intent and my heart; when I was actually being closed minded and unteachable.

Brooks S - in the first area where the motion was presented and in the following area, you questioned the intent behind the makers of the motion and you also tried to explain guidelines. In doing so, you made a statement that the motion itself was a "dope fiend" move. Boy did I take that personal in a time where I was being sensitive' when in hindsight it was just that. I presented the motion and pretty much brought with it the air that "We made the money and we should say what is done with the money." I was wrong.

In working steps 4-7 over this situation, I realized the motion itself was a great example of how to spend or use the money. But there were hundreds of ways to utilize the blessing we have achieved with a successful NA in May. When I presented the motion, I created the discord by making it personal, not adhering to our guidelines, and being unwilling to listen. The motion should have been brought up as a discussion.

Bill B – I know you felt unheard, and I spoke over you in an attempt for my voice to be greater. You are wanted and needed here just like me.

James R – As chairperson I left you in an awkward position of scrambling and chairing a clusterfuck.

GSR's & committee members of area – What you witnessed was "little" Amanda throwing a temper tantrum. My husband sees her often and is grateful to have proof she exists.

This journey has been awkward, humbling, and scary to see how far I've come and how much farther I need to grow. As a recovering addict this has pushed me into working the traditions. It has given me a desire to go outside of my thinking I'm stupid or dumb and its helping me understand I have been unwilling to learn myself. I have relied on others to do the "work." I should have been wiling myself to read our guidelines and guiding documents myself. This is what I do. I cause chaos then blame others for participating in the chaos.

I love you all, and I am sorry for causing discord and dis-unity by making members uncomfortable sharing their ESH. What I've learned through this process is I am loved, wanted, and needed with my flaws and all. We are all trying to learn a new way to live and with that new way, I have to remain willing, open-minded, honest, and humble. I am so grateful for the gift of my life. And with that gift comes responsibilities. I took advantage of my gift, I am sorry.

I look forward to learning this new way and doing my part to own my part and actively working to make it better. Thank you guys, so much for loving me in spite of me. So please take my amends and go on this amazing journey with me.

Working the steps, working the traditions, and working the concepts. Most importantly DO NOT USE NO MATTER

WHAT! Is there any harm I've caused that was not mentioned? Are there any amends that weren't sufficient? Is there anything else I can do to make it right?

Intent: To put recurring process in place that, 1. Ensures that all basic text requests from our groups within the guidelines set out above continues to be subsidized, 2. To not leave any subcommittee underfunded, and 3. Provide for distribution of any excess funds so that our area is not left sitting on an unused sum of money.

Rationale: Up until 3 years ago this has not been an issue, as we used all the basic text funds. But with recent financial successes of the NA in May event, we have had excesses. Last year we made a one-time donation to VRC, but wanted to put something in place that would deal with it on an ongoing basis. Because NA in May used to be VRC fundraiser every year before we created the Basic text fund, some of the funds going to the VRC seemed to make sense. And that is balanced by keeping the other half of any excesses here for the subcommittees to better carry the message. The \$4,500 amount was determined as follows: For the past several years of the basic text fund, the cost has been \$2,400-\$2,800 annually. So we started at \$3,000 as an amount that should cover a year's usage easily. Then add 50% more for just in case of a lean year for NA in May or an expanded need due to growth of groups, etc.

I. PURPOSE

- A. To consider any input referred by the ASC and subcommittees, and upon deliberation, Give recommendations to the Area and those subcommittees
- B. To provide written response to any issues submitted regarding Tradition violations
- C. Act as an advisory board and will update policy as needed
- Deals with those things which are the policy of NA which are expressly stated in our Traditions
- E. Application of the Traditions at the local level is the concern of the Policy Subcommittee

II. COMMITTEE MEMBERS

A. CHAIRPERSON

1. Requirements

- a. Minimum four years clean
- b. Minimum two years ASC experience, i.e., GSR, Administrative committee, subcommittee chair
- c. Willingness and desire to serve
- d. One year commitment
- e. Understanding of Twelve Steps and Twelve Traditions through application

2. Duties

- a. Prepares the agenda for each meeting
- b. Presides over all meetings of the WTAPC
- c. Coordinates and keeps records of the WAPC
- d. Must attend all ASC meetings

B. VICE-CHAIRPERSON

1. Requirements

- a. Minimum two years clean
- b. Minimum of one year prior service experience
- Willingness and desire to serve
- d. One year commitment

e. Understanding of Twelve Steps and Twelve Traditions through application

2. Duties

a. Performs all duties of the chairperson in their absence

C. SECRETARY

1. Requirements

- a. Minimum one year clean
- b. Minimum six months prior service experience
- c. Willingness and desire to serve
- d. One year commitment

2. Duties

- a. Responsible for keeping a written record of all policy meetings
- b. Keeps mailing list of all members
- c. Responsible for typing, copying and distributing minutes to all members at the next committee meeting

I. REQUIREMENTS FOR MEMBERSHIP

- A. The chair is elected by the ASC. All other officers are elected by the Subcommittee itself.
- B. A minimum of one year clean is strongly suggested for membership to this Subcommittee.
- C. Six months prior service commitment is suggested for members.
- D. An understanding of Twelve Traditions through application

II. GOALS FOR POLICY SUBCOMMITTEE

- A. To create a defined and complete policy for the Area and its subcommittees. Per the ASC, "to clean up the guidelines". This was voted in unanimously, and a copy of the guidelines to be sent to all members.
- B. To outline suggested guidelines to all the subcommittees.
