NA in May - Hi family,

Sadly, I am reporting that the NA in May committee has decided to postpone this years event until next May 2021. We had our last meeting today at noon. The vast majority of the committee voted to postpone this even in lieu of the pandemic

and did not feel like it would be in the best interests of NA and its members with us moving forward. There are too many unknown factors. As a committee, we must present a written plan to Meeman Shelby Forest State lark on how we put in place to follow all guidelines stipulated by the park which includes social distancing. We don't see how we could successfully pull off this event with social distancing in place. It seems likely it would not be well attended. The thought of our main purpose outside carrying the message is to fund the basic text fund. At this moment, we have \$3,694.99 in the NA in May account. Before all is said and done, we should still have a decent amount to add to the already \$7,515 in the basic text fund as of today. Therefore, we expect there to be a sufficient amount of funds to carry us through May 2021. We will be offering to all those already registered three options. First is to rollover registration to May 2021. Second, we ask the money to be donated. Lastly, we offer a full refund. We are allowing those registered time up until September 17 to make that decision. In the meantime, the committee will tie up all loose ends with expenses and discussing setting up 2021 to be ahead of said expenses we can afford at this time. At September's area, we will then donate the remainder after set asides to the basic text fund. Our next mtg is Sunday July 26 at noon via zoom.

OPEN FORUM TOPICS

Leigh Ann F- P.O. box, set aside for web hosting fees that aren't being used

Leigh Ann went and paid \$150 for safe deposit box and then \$150 was automatically deducted. Also wondering if PO box expired because it hasn't been paid since May 2019. There are \$300 set aside for web hosting that is not being used. Lucy expressed that the extra \$150 could be put toward a payment for next year and the treasurer just needs to not pay for it next year, unless money can be returned. Lucy will reach out to Brad about web hosting fees. Tayler brought the idea to have some type of database in place to hold information related to banking, PO box, safe deposit box, etc. for treasurer and secretary to pass along to members taking over positions so that information doesn't get overlooked when new people take positions.

Terry F- brought the topic of what's being done to plan for reopening meetings and people who are unable to attend live meetings. She shared that her home group is going to have one meeting a week on zoom to provide additional meetings available to those who can't or don't feel comfortable having in-person meetings for precautions. Kat R: For Clean Air we talked about continuing to zoom even when we meet in person. The group does not feel comfortable turning someone away for limited capacity. We would like to have options. Tom B: We are going to try to have a hybrid meeting at our home group and if it goes well we will continue to do that. Nancy S. asked for clarification for hybrid vs in person meetings and Terry B. let her know the hybrid doesn't pick up the voices well on the hybrid with the safe distancing rules in place and the 6ft apart and masks make it difficult to pick up all words in the meeting.

<u>Marcus</u> shared that he has been providing speaker meetings at Lakeside Behavioral Health, and these are separate from H&I. He shared that there is a suggestion to have 6 months clean to share. There is no need to sit in at 3 months clean because the individual speaking is the only person present. Marcus asked if anyone is interested in sharing their story they can contact him for more information. He said that there are not speaker meetings at this time due to COVID19. Lucy asked if Lakeside would be willing to have speaker meetings via Zoom and Marcus is going to find out from Lakeside.

Bill S- How can literature be provided to homegroups right now if they need it in person. (Last area Geoff B. & Bronson R. said to get in touch with them and they could make sure homegroups or subcommittees that needed literature could get what they need)

OLD BUSINESS

1st Motion: RCM Motion

Motion by: Craig G from: PR Chair, Second: Julius H. from: MTA

Motion reads: To change article XII, Section 12C from- C. Six thousand dollars seed money for the upcoming convention committee To- Article XII, Section 12C. To provide the VRC subcommittee an annual operating budget of \$20,000. The VRC subcommittee can make a withdrawal from that budget to open up their bank account but the remaining funds can be accessed as necessary.

Intent: To provide funding for a subcommittee of the VRSC without relying on the subcommittee to put on fundraisers. If we do not require H&I, Outreach, and PR to do fundraisers to provide for their budgets, it doesn't seem practical to require VRC to do fundraisers to provide their service. Per our area guidelines I'm supposed to offer a pro and con

Pros: The Region has most of this amount already set aside. The VRC will not have to depend so much on Area fundraisers. If the convention loses money, the money will be there to cover the loss.

Cons: It's a lot of money

Yes: 3 No: 6 Abstain: 2 (We vote no for our area to take back to RCM)

2nd Motion: Maker, Regional Committee Chair & Seconded by Policy & Procedures Chair

Motion reads as follows: To change WTASC Guidelines Section MOTIONS, VOTING PROCEDURES AND OPERATIONS Part C. Quorum Item 2. FROM "Official quorum must be reached by 2:30 PM. If not, the ASC must be rescheduled. Official quorum will be re-established before new business based on voting participants." TO "A quorum is required for the WTASC to conduct business. Official quorum must be reached by second roll call. The quorum shall be established by the Chairperson after roll call at the beginning of WTASC. If failure to meet quorum then the Chairperson shall wait until 2:30 p.m. and call roll again. If no quorum can be established then no official business will be conducted. However, the WTASC meeting may continue in order for reports to be read and open forum to occur."

Intent: To allow WTASC to proceed with a limited scope. This would be beneficial to the groups present as well as Area as a whole.

1st Pro: Groups can still give their report, let anyone know any struggles they are having or announce bdays.

2nd Pro: Groups can still get literature if they need it and make donations to WTASC etc...

1st Con: Still having OPEN forum sometimes results in making a motion and since we cant have official business, would the homegroup GSR's not in attendance have the option to be well versed on the OPEN forum discussion. Reading about it in the minutes doesn't necessarily do justice.

2nd Con: Changing Policy based on immediate quorum issues causes a precedent for future issues to try and be solved by changing policy which undermines the purpose of having Policies and Procedures
