** Discuss with your groups about sending a regular donation to the Southern Zonal Forum. We will later be asked to vote on this. The zone provides important functions to its member regions which in turn trickles up to the groups. The zone assists the regions with any problems they might be having, similar to how the area assists the groups. The zone provides training opportunities like how to facilitate workshop on various things – like the CAR/CAT workshops, Issue Discussion Topic workshops. It is great for networking amongst the delegates. Attending the World Service Conference can be a daunting experience especially going there and seeing a couple hundred people from around the world and you don't know anyone. Through the zonal forum, the delegates know those delegates and alternates from the 10 regions in the central part of the united states. It's important that our region do its part to support the zone financially on a regular basis. This won't require any more money from the groups. It just means that some of the Region's funds will go to the Zone and some to NAWS.

We received from an outside entity information about a lawesuit against NAWS regarding the Fellowship Intellectual Property Trust. I'm not sure at this time what has been released to the delegates but copies of the lawsuit and NAWS response was floating around the internet. I'm sure more will be revealed after the World Service Conference.
